

Sealed Tenders must be submitted in the prescribed form (attached on page 3 of this <u>notice</u>) and must be accompanied by a deposit in the form of a money order or of a bank draft or cheque certified by a bank or trust corporation payable to the municipality and representing **at least 20 % of the tender amount.**

The municipality makes no representation regarding the title or any other matters relating to the land to be sold, including but not limited to the potential existence of environmental contamination, estates and interests of the federal or provincial governments or their agencies, easements and restrictive covenants, and interests acquired by adverse possession. Responsibility for ascertaining these matters rests with the potential purchaser.

This sale is governed by Township By-Law 2010-27.

The successful purchaser will be required to pay the amount tendered plus accumulated taxes from date of acceptance of purchase, penalties and interest, HST if applicable, and the relevant land transfer tax within 14 days upon notification. The municipality has no obligation to provide vacant possession to the successful purchaser.
