

# **The Township of Plummer Additional Recreation Equipment: Use/Rental Regulations**

(Approved Feb 20/19 ResIn #2019-35)

1. I am 18 Years or older, OR under the age of 18 with parental consent, and acknowledge that I am capable and of suitable health to use the equipment in a safe and proper manner.
2. I acknowledge receipt of the above described equipment and agree that the equipment was inspected by myself (and an appointed member of Plummer Township) at the time of pick up and accepted to be in good and serviceable condition.
3. I take full responsibility for the care of the equipment and will ensure it is used only for its intended purpose.
4. I acknowledge that all equipment lent by The Township of Plummer Additional is the property of The Township of Plummer Additional.
5. I agree that The Township of Plummer Additional is not responsible for any manufacturing defects in any borrowed equipment AND if borrowed equipment becomes unsafe or in a state of disrepair, I will immediately discontinue use of the equipment and return it to The Township of Plummer Additional.
6. I agree to return all equipment on or before the due date and in the same condition as when it was borrowed. I understand that failure to return equipment on time can result in the forfeiture of my lending privileges.
7. I agree to pay The Township of Plummer Additional for all lost, stolen or damaged equipment that is signed out on this form. Where applicable, any unpaid amounts will be deemed as taxes and added to the Roll Number and collected as Taxes. This payment will include the price of the equipment (replacement value) plus a non-refundable \$10.00 administration fee if lost, stolen or damaged.
8. The Township of Plummer Additional Recreation Equipment is set up for individual and/or non-profit group use. The Township of Plummer Additional Recreation Equipment is not to be used for professional business or "for profit" ventures nor for use in any competition or race.
9. I agree to indemnify and save harmless The Township of Plummer Additional, its agents and employees harmless from any claims for injury or property damage to person or property by this equipment.
