COA & Planning Meeting:

COA 1. Bill 109/23 – Planning Updates (Memo)

- Chris Jones discussed how Bill 109 and Bill 23 will affect planning related endeavors within the Township.
- Under Bill 109, decisions are to be made on Zoning By-law applications within 90 days, or are subject to a portion/all of the application fees being refunded to the applicant.
- Bill 109 resulted in increased funding for the Ontario Land Tribunal to clear current case backlog.
- Under Bill 23, public meetings are no longer required for subdivision approvals, and third-party appeals are longer valid for minor variances, consents and plans of subdivisions.
- Bill 23 outlines new regulations with respect to how additional dwelling units can be constructed. Additional dwelling units cannot be prohibited on parcels of urban residential land.

j) Trunk Road Plowing

WHEREAS seasonal road maintenance, specifically for the section of Trunk Road from Highway 638 to Jeffrey Road, is currently provided between the Township of Plummer Additional and the Town of Bruce Mines, and; WHEREAS there have been recent changes to Trunk Road, primarily due to the stop up and closure of a section of Trunk Road that lies easterly of the turnaround at the Bruce Mines Cemetery and continues to Jeffrey Road;

AND WHEREAS with this closure of the roadway, the Township of Plummer Additional is no longer required to access any property on the new section of Trunk Road between the Cemetery turnaround and Highway 638, with exception to residences located at 12 and 24 Trunk Road;

AND WHEREAS the Town of Bruce Mines still needs access to the Bruce Mines Cemetery and the Lagoon from time to time;

NOW THEREFORE BE IT RESOLVED that this Council calls on the Town of Bruce Mines to take over all winter maintenance on Trunk Road, effective March 1, 2023;

AND THAT in exchange, the Township of Plummer Additional will plow all of Copper Bay Road, including the section of the roadway located in Bruce Mines, which will be plowed at no extra charge back to the Town of Bruce Mines. CARRIED
