## INSTRUCTIONS TO BIDDERS

### 1. Submission Requirements

- Tenders must be submitted in a sealed envelope or by approved electronic method.
- Clearly mark the submission as: “*Tender – Sale of Single Axle Truck*”.
- Include bidder’s full name, address, phone number, and email.

### 2. Closing Time

- Tenders must be received before the specified closing date and time.
- Late submissions will not be accepted.

### 3. Bid Amount

- Bids must be in Canadian dollars.
- HST must be clearly indicated.

### 4. Irrevocability

- All tenders shall be irrevocable for a period of **30 days** following the closing date.

### 5. Deposit

- A deposit of 10% of bid amount must accompany the tender.
- Deposits must be in the form of certified cheque or bank draft payable to the Township of Plummer Additional.

### 6. Inspection

- Bidders are encouraged to inspect the asset prior to submitting a bid.
- No claims will be made after submission regarding condition.

### 7. Acceptance

- The Township reserves the right to accept or reject any or all tenders.
- The highest or any tender will not necessarily be accepted.

### 8. Award

- The successful bidder will be notified in writing or by email.

### 9. Payment Terms

- Full payment must be made within ten (10) business days of award.
- Failure to complete payment may result in forfeiture of deposit.

### 10. Transfer & Removal

- The asset must be removed within ten (10) business days after full payment.
- All costs associated with removal are the responsibility of the purchaser.
